Therefore, studying Porter's life and works with a focus solely on regionalism while neglecting other historical and material conditions would be hasty and superficial. Porter's extensive and frequent travels undoubtedly enrich and add depth to her works both in content and meaning. In many of her novels, the unique geographical backgrounds—Mexico, Europe, the Southern United States, New York—were places where the author had personally visited, carefully observed, and incorporated into her works.

Although Porter's works bear strong autobiographical imprints, they can be considered "semi-autobiographical" rather than a straightforward recollection. For instance, in "Pale Horse, Pale Rider," Porter portrays a nearly forgotten and enduring epidemic—the massive influenza pandemic of 1918 to 1919 that spread from the United States to various parts of the world, especially to the European countries involved in World War I. This epidemic resulted in the deaths of a large number of soldiers and civilians. The theme of trauma and disease in this work is related to the author's own experiences with illness, but it has undoubtedly undergone artistic processing.

2.2 Southern Narrative

Katherine Anne Porter, born in Texas, did not receive the unequivocal recognition as a Southern writer. Her status is often overlooked, partly due to the pervasive male-centered ideology in the traditional Southern mindset, which has overshadowed Porter as a female author. Another reason is that Porter's novels do not typically feature the cowboy heroes or adventurous characters characteristic of the Western genre. As a strong-minded female rebel, Porter certainly wouldn't deliberately venture into these unfamiliar themes. However, Porter did not completely avoid the influence of the South, especially in her stories about Miranda, which often draw inspiration from the ancient Southern traditions. Typical Southern beauties, along with other Southern legends and myths, find their place in Porter's novels.

Undoubtedly, Porter's grandmother had a significant influence on her. Her grandmother belonged to a relatively affluent generation, part of a traditional Southern family. It is said that even the governor visited their home. However, by the time of Porter's father, the family's financial situation had deteriorated significantly. Their house was humble, small, and lacked the columns mentioned in the novels—columns only appeared in the marble pillars at her grandmother's grave site after her passing. After her grandmother's death, the house and land were sold, and the representation of the traditional Southern spirit disappeared. As a female writer emerging from a Southern family, Porter seems to scorn the declining South, looking forward with anticipation and hope to a new life. Simultaneously, she expresses her attitude towards Southern myths—one must face reality and not dwell in the memories of the past.

2.3 Narrative Writing Techniques

Porter's works excel in nuanced and vivid character portrayals, whip-smart explorations of thought, meticulous and refined diction, and an often elegant and composed style, showcasing perfection even in her short stories. Critics laud her ability to adeptly reflect the pain, disappointments, loneliness, and the elusive quest for understanding in people's lives. However, she neither adopts a cynical outlook nor succumbs to futile and

superficial sorrow. Instead, she conveys her perspectives with an objective, calm demeanor that is rich in emotions and poetic tone. Her works often prompt readers to engage in profound contemplation about life, existence, and self. As a distinguished American literary figure, Porter demonstrates skillful storytelling, tightly gripping readers' interests through unique narrative techniques that unveil her artistic world.

2.4 Feminist Narrative

Regarding Porter's Miranda series novels, domestic scholars have shown considerable interest in the development of feminism in Katherine Anne Porter's novels, but their emphases vary. Porter's works are thematically rich and highly inclusive, with some themes recurring throughout her body of work. One such prevalent theme is that of women, especially women's growth and transformation. Porter's protagonists often exhibit strong rebellious tendencies, rebelling against old traditions and orders, and fervently seeking personal spiritual independence while attempting to break free from the confines of a patriarchal society. For instance, in the Miranda series stories, the theme of resisting the unjust treatment of women in a patriarchal society is prominent, and the awakening of female consciousness is a key thread running through her novels. Although a strong sense of female self-awareness consistently appears in Porter's novels, this independent consciousness can sometimes be hesitant and self-contradictory.

As a female, Porter relatively modest literary output, Katherine Anne Porter's works, shaped by her experiences in the South, Mexico, the urban East, and the Rocky Mountains, consistently demonstrated a deep connection to her past. She often incorporated aspects of her own life as the central theme when memories held personal significance, diligently recording details and accumulating notes until a coherent pattern emerged.

Porter's works consistently demonstrate empathy for those who dedicate their lives to alleviating the perpetual, incurable pain caused by mutual harm and torment among humans. She aimed to expose this historical event and fulfill her longstanding desire. Recognized among numerous novelists, Katherine Anne Porter's unique style lies in her adept handling of themes and character portrayals. Porter's short stories, whether in terms of background, themes, narrative techniques, or writing style, possess a unique and distinctive quality, offering significant research value that remains relevant and influential to this day. Her ambition, emotional depth, and the scope of influence—from stark realism to boundless compassion, from the commonplace to the lyrical—remain unparalleled in her era, with few successors.
